Type of Information Collected & How It's Used

Partnerships for Children/Foster Community gathers personal information; name, addresses, email addresses, phone numbers, only when voluntarily submitted by you. If you fill out an inquiry form, personal information will be collected from you to process that request.

We will use personal information submitted by you to send information: Foster Community updates, Partnerships for Children updates, volunteer opportunities, etc. You can, at any point, elect not to receive such materials. If you complete a request to learn more from one of Foster Community's partner organizations, that organization will be given the contact information you provided and they will reach out to you directly.

Security of Information

Any information submitted through Foster Community's website is stored within a constituent management database with access to the database restricted to personnel with legitimate business need to access or modify the information contained therein.

Sharing of Personal Information

Companies may be engaged by Partnerships for Children/Foster Community to perform a variety of functions, such as assisting with data collection, providing technical services for our website, etc. Such companies may have access to personal information if needed to perform certain functions. However, these companies may use such personal information only for the purpose of performing that function and may not use it for any other purpose.
